### ***Approval of Application***

It takes approximately 24-72 working hours for final approval. We can continue to offer the apartment until final approval; confirmation and a signed lease are completed.

### ***Condition of the Dwelling***

THE APARTMENT OR HOUSE YOU HAVE APPLIED FOR WILL REMAIN IN ITS CURRENT CONDITION UNLESS AGREEMENTS ARE MADE AT THE TIME OF APPLICATION other than the fact that all dwellings will be well cleaned, painted, the carpets will be cleaned and all necessary maintenance performed (as defined by the management).

### ***Lease Period***
